xv. Open Sharing Session –

--Just a reminder that September's ASC is moved to the second Sunday of September, which will be the 10^{th} of September.

The following quoted and italicized portion is a letter written to the body regarding a challenge arising at/during the Thursday night meeting:

-- "First and foremost, I would like to openly apologize for any harm directly or indirectly I have caused to the members of the Thursday night Ladies and Gentlemen group of Narcotics Anonymous.

The following topic of discussion is not intended to use NA literature as a weapon but to acknowledge and discuss a difficult and sensitive topic in an atmosphere of recovery, where principles can come before personalities. As "personal recovery depends on NA unity" (Pg. 61, Basic Text), are we doing everything we can to welcome everyone? Tradition 4 expresses that, "Each group is autonomous, except in matters affecting other groups or NA as a whole." (Pg. 67, Basic Text). It was brought to my attention that our area may have an influx of transgender or non-binary individuals that may be impacted from having a men and women's only meeting. Special interest meetings, more recently known as common needs meetings, are a common practice within NA as a whole. NA world service published Bulletin #18 in 1988 that states, "There does not appear to be anything in the Twelve Traditions which cautions groups against holding special interest meetings, provided that the group has no requirement for membership other than the desire to stop using" (NA World website, Special Interest Meetings Bulletin #18". Tradition 5 states, "Each group has but one primary purpose – to carry the message to the addict who still suffers" (Pg. 67, Basic Text). Our literature goes on to express in Tradition 4 that, "Like group conscience, autonomy is a two-edged sword. Group autonomy has been used to justify violation of the Traditions. If a contradiction exists, we have slipped away from our principles." (Pg. 67, Basic Text). Once again, I ask, are we doing everything we can to welcome everyone? Tradition 3 states, "Desire is our only requirement. Addiction does not discriminate. This tradition is to ensure that any addict, regardless of drugs used, race, religious beliefs, sex, sexual preference, or financial condition is free to practice the NA way of life." (Pg. 65, Basic Text). Some may view this as an outside issue, however, this could affect NA as a whole, as transgender and non-binary people are individuals who attend our meetings. We are a small area and have only one in-person meeting on Thursday night, which could be interpreted as exclusive to someone seeking a meeting who identifies as transgender or non-binary. Tradition 10 states, "Our recovery speaks for itself. Our Tenth Tradition specifically helps protect our reputation. This tradition says that NA has no opinion on outside issues. We don't take sides. We don't have

any recommendations. NA, as a fellowship, does not participate in politics; to do so would invite controversy. It would jeopardize our Fellowship. Those who agree with our opinions might commend us for taking a stand, but some would always disagree. With a price this high, is it any wonder we choose not to take sides in society's problems? For our own survival, we have no opinion on outside issues." (Pg. 74, Basic Text). Does having a men's and women's only meeting contradict our primary purpose and traditions? Regardless of our personal opinions, how can we ensure that everyone is welcome at every group in our area? Tradition 5 states, "If our group purpose were anything other than to carry the message, many would die and few would find recovery." (Pg. 68, Basic Text).

The intent of presenting this information, is to bring about a discussion where personal opinion is set aside; to ensure that we are carrying that message to any addict who has a desire to stop using and provide an atmosphere of recovery. Tradition 12 states, "We have heard the phrase "principles before personalities" so often that it is like a cliché. While we may disagree as individuals, the spiritual principle of anonymity makes us all equal as members of a group. No member is greater or lesser than any other member. The drive for personal gain in the areas of sex, property and social position, which brought so much pain in the past, falls by the wayside if we adhere to the principle of anonymity. Anonymity is one of the basic elements of our recovery and it pervades our Traditions and our Fellowship. It protects us from our own defects of character and renders personalities and their differences powerless. Anonymity in action makes it impossible for personalities to come before principles." (Pg. 76, Basic Text). Is a men's and women's only meeting ensuring that the principle of anonymity is being upheld? Tradition 2 states, "True spiritual principles are never in conflict; they complement each other. The spiritual conscience of a group will never contradict any of our traditions." (Pa. 64, Basic Text). Tradition 2 goes on to state, "An atmosphere of recovery in our groups is one of our most valued assets, and we must guard it carefully, lest we lose it to politics and personalities" (Pg. 64, Basic Text). Is a men's and women's only meeting following the spiritual principles of NA as a whole? In summary, are we doing everything we can to welcome everyone? Does having a men's and women's only meeting contradict our primary purpose and traditions? Regardless of our personal opinions, how can we ensure that everyone is welcome at every group in our area? Is a men's

and women's only meeting ensuring that the principle of anonymity is being upheld? Is a men's and women's only meeting following the spiritual principles of NA as a whole?

Potential Solutions:

- * Add a third split off meeting.
- * The home group identifies a member who can lead said third meeting provided on circumstance.
- * Open another meeting.
- * Combine the men's and women's meeting.
- * After reading of opening literature and before open discussion, present an opportunity for members to go around and introduce themselves and state their preferred pronouns.

Being mindful to maintain an atmosphere of recovery."

- --A member spoke on their point of view and concerns regarding the challenges that came from this situation. Pointing to the important and larger topic of inclusion and/or exclusion based on one's preferred pronouns, sexual identity, and LGTBQ.
- --The ASC Chairperson pointed out that, via our bylaws, the ASC does not govern the groups.
- --Regarding NA Traditions, we should not be instructing fellow NA members, newcomers, and the like on what meeting that said individual needs to or not to attend. A home group can suggest a meeting that someone may be more comfortable at a different meeting or a "special interest" style meeting but should not be turning away anyone coming into the rooms.
- --Regarding the challenges at the Thursday Night meeting; after the chairperson had several discussions with experienced members it seems that the challenge at the Thursday night meeting came down to a misunderstanding or miscommunication, for the most part. Also, it was noted that the specifics are not an area issue, and the discussion was tabled after the 20-minute time allotment.
