B. Hospitals & Institutions – Richard M.-

H&I met at 3pm with a total of 7 members present. Most of last month's commitments were met. We spoke specifically about adding sunshine lady house back onto our schedule, returning basic texts as a credit for intro to NA booklets as well as procedure and tradition concerns. We are continuing to move forward in hopes of picking up more facilities as well as more trusted servants to take the meetings in. Six months clean time to share, one-year clean time to chair a meeting. We have heard that Boxwood is requesting one-year clean time to share as well. Please don't let that deter you. We could always use help. I will be putting a motion in for \$194.00 of the current remaining budget as well as a credit of \$56 for the return of four basic texts this will give us 100 intro guides to narcotics anonymous. To those that aren't clear, the intro guide has I think it's 4 of the IP's as well as the couple of the chapters from the basic text. Thank you for letting me serve.

C. **Literature** – Natalie M.–

Good afternoon RSC,

In light of the recent news of NAWS increasing their literature prices, I have compiled some information for the committee in the hopes of providing some clarity on how this will impact our Area.

- 1. NAWS price increases will begin on 1 January 2026. Most items in their inventory will increase by 15%, though a few items will remain at the same price or will only increase slightly in price (a few. cents) when bundled.
- 2. Free State will also increase their prices by 15%. Free state for those who may be unaware is a region in Maryland that I do the vast majority of my ordering due to the fast-shipping times.

- 3. There is no documented plans to increase shipping prices; we are assuming as of today that the shipping costs will remain the same. Today, they are percentages based on amount order. Specifically, for both Free State and NAWS, they are as follows:
- 4. \$ 10.00 \$ 25.00 add \$6.00
- 5. \$ 25.01 \$ 50.00 add \$9.00
- 6. \$50.01 \$150.00 add 17%
- 7. \$150.01 \$500.00 add 12%
- 8. \$500.01 and up add 8%

To give an example of the way costs are calculated today: A Basic Text is listed at \$14.00 on our Area Literature Form. If I order it from Free State, it is \$13.60. This is a \$0.40 upcharge, to account for some shipping. This is approximately a 3% shipping cost, compared to the 8-17+% cost charge from ordering the literature depending on the amount as detailed above. When the prices increase in January, the Basic Text increases in price to \$15.75 (15%) on NAWS and Free State. In order to keep the same discounted shipping rate for groups we offer today, we would need to raise our price for the basic text in our Literature Form from 47 cents to \$16.22. This may seem like a lot, and some may understandably resist the idea of changing this price, but 15% adds up in bulk ordering when shipping is already discounted. To give you a recent example: My most recent Literature Order was \$597.65 before shipping. Again, not factoring in shipping, if the prices of all of the items in this order were increased 15% to order but not reflected in the prices to our individual home groups, this would be \$88 (\$88.42) additional cost on this order to Area. If Literature orders get placed around 6-8 times a year at similar totals to minimize shipping costs, this is somewhere between a \$500- and \$750-dollar deficit annually. Given the downward trend in group donations over the last few years, this could have significant impact on our balances and budgets for the next fiscal year. That being said, I believe it is fair to allow for a buffer to allow home groups the ability to buy literature at the lower prices for a few months until the next order is placed, as much of the literature in the inventory will have been purchased at pre-increase prices for at least a couple months. Therefore, it is my intention, should I continue to serve as Literature Chair, to raise our prices at 15% to remain consistent with NAWS and other regions such as Free State for orders placed to be filled at our March ASC meeting on March 2nd, keeping the shipping calculations exactly the same at approximately 3% of the NAWS/Free State price. The price increase will be after our February ASC meeting on the Literature Order forms, so that any literature orders for March will reflect the correct amount due. I will work with the PR chair to ensure the Form prices are updated at that time. Note that I have placed a bulk order this month to ensure we are able to fill orders at the same price through February area. Finally, I will be holding a Literature Subcommittee meeting at 12:30 PM on Saturday, December 6th at Trinity Episcopal, in the event that anyone would like to participate in any discussion on the topic prior to the increase in price. Feel free to join if you have an interest in shaping the Subcommittee decisions and all are welcome and encouraged to come.

Motion:

To change the wording of Article 12, Section 1 to say "New meetings must attend one (1) ASC business meeting to be added to the online meeting list. New meetings must attend three (3) consecutive ASC business meetings before being included on the printed meeting list and before being provided a new meeting starter kit."

Intent:

To allow new meetings to be listed on the online meeting schedule after attending one ASC, ensuring quicker accessibility for addicts seeking recovery, while still requiring three ASC attendances for inclusion on the printed meeting list and for receiving a startup kit.

Rationale:

The platform used by the RANA website to display meetings, the Basic Meeting List Toolbox (BMLT), is a web-based utility maintained at a broader fellowship level. It is not managed by the Area but simply utilized as an efficient tool for keeping meeting information updated and accessible. Allowing new meetings onto the BMLT after one ASC ensures that more addicts can find recovery sooner, directly supporting Tradition Five (carrying the message to the addict who still suffers). Changing the language balances accessibility with accountability. Online listing after one ASC provides immediate visibility, while retaining the three-ASC requirement for printed lists and startup kits ensures consistency, stability, and financial accountability, in line with Tradition Seven (self-support) and Concept Eleven (responsible management of funds). Finally, this has already been the practical approach in recent years; the bylaw change simply brings our written policy into alignment with our established practice.
